# Two Harbors Investment Corp. Announces Conversion Rate Adjustment for its Convertible Senior Notes Due 2022

New York, June 28, 2018 – Two Harbors Investment Corp. (NYSE: TWO) today announced an adjustment to the conversion rate for the company's 6.25% convertible senior notes due 2022 (the "Notes"). This conversion rate adjustment is being made pursuant to the supplemental indenture governing the Notes as a result of the company's previously announced second quarter 2018 common stock cash dividend of \$0.47 per common share. Effective immediately after the close of business on June 29, 2018, the new conversion rate for the Notes will be 62.0780 shares of common stock per \$1,000 principal amount of the Notes. Currently, the conversion rate for the Notes is 61.7770 shares of common stock per \$1,000 principal amount of the Notes. Notice of the conversion rate adjustment was delivered to holders of the Notes and Bank of New York Mellon Trust Company, N.A., as trustee, in accordance with the terms of the supplemental indenture governing the Notes.
